The Foundation have been supporting disadvantaged groups since **1985**, funding over **10,500** projects to the tune of **£37.5M**. This would not have been possible without the support of Lloyds Banking Group, our sole donor.

We are delighted to launch our strategy for 2020 - 2023, 'A Vision for the Future'. Based on research we carried out in the Third Sector - with non-profit organisations, recently funded groups and umbrella organisations supporting the community and voluntary sector, our Strategy will see the creation of four new grants programmes. Grant programmes have been streamlined to ensure charities can spend more time delivering their essential work, rather than completing lengthy application forms.

- £2,500 £10,000
- 12 month grant
- Rolling programme
- Maximum 4 month turnaround for decision
- Funding to improve the lives of those who are disadvantaged and/or disabled
- Aimed at charities with an income of under £1M
- Evaluated after 12 months



LONG TERM COMMUNITY GRANTS

- Up to £50,000
- Over 3 years
- Programme opening in January, closing in February each year
- 'Grants Plus' approach
- Funding to improve the lives of those who are disadvantaged and/or disabled
- Monitored annually
- Aimed at charities with an income of under £1M

- Up to £20,000
- 2 years

IS YOUR GROUP ELIGIBLE TO APPLY?

- Registered Charity with HMRC and/or Charity Commission NI
- Beneficiaries of Charity reside in NI
- Income of Charity under £1 Million
- Charity supports those who are considered disadvantaged and/or with disabilities
- Charity has a set of independently examined accounts
- Charity has a Board of Trustees, with minimum number of Trustees (as per governing document)
- All relevant policies are up-to-date and reviewed periodically

OUTSIDE OUR REMIT

- Individuals and students
- Business loans and finance
- Endowment funds
- Organisations that are insolvent
- Sponsorship or fundraising events
- The environment
- Activities that are normally the responsibility of local/central government
- Animal welfare
- Umbrella organisations
- Capital Builds (except in case of disabled access)
- Travel outside of Northern Ireland
- Promotion of religion
- Hospitals and medical centres
- Schools and universities (except for projects to benefit pupils with special needs)
- Charities with more than 12 months reserves would not be seen as a priority
